The following documents shall be attached to the notification: (i) if your legal person is represented by a proxy, the original or an officially verified copy of the power of attorney with the notarized signature, authorizing such proxy to act on behalf of your legal person in the matter of filing of the notification, dated on or before the date of signing of the notification; (ii) the original or an officially verified copy of an extract from the relevant register of your legal person and/or the proxy (if the proxy is a legal person) or another official document which confirms that the person who signed the notification, or the power of attorney under item (i) above respectively, is authorized to act on behalf of your legal person, or the proxy respectively, issued on or before the date of signing of the power of attorney under item (i) above (applicable to the extract of your legal person) and on or before the date of signing of the notification (applicable to the extract of your legal person, if your legal person signs the notification itself, and to the extract of the proxy, if the proxy signs the notification) but not earlier than 3 months before the date of the notification. All documents must be in Czech, Slovak or English language. Documents in other languages must be accompanied with a simple translation to any of the above languages.
